



## Bandwidth Service Agreement

This Agreement is entered into on **01 January 2025** by and between **XYZ College** [First Party] and the Bangladesh Research and Education Network (BdREN) Trust [Second Party] to ensure uninterrupted high-speed internet connectivity, which will support the academic and administrative operations of **XYZ College**.

### BdREN's Responsibility:

- BdREN will provide high-speed internet Bandwidth "**100 Mbps**" to **XYZ College (Building-1)** from **01 January 2025**.
- BdREN will provide 10 (ten) ZOOM IDs for the teachers of **XYZ College**. Email addresses needed to be filled up in a prescribed format to activate the Zoom IDs.

### XYZ College's Responsibility:

Pay BdREN a sum of BDT **45,000.00** per quarter (**Forty Five Thousand**) only at the beginning of each quarter against subscribing "**100 Mbps**" [**100 Mbps \* BDT 150 /Mbps \* 3 Months**]

### Payment Terms:

- Billing will start from the effective date of the contract. Any arrear payment shall be deemed payable with invoice issued by the second party.
- The invoice will be issued by the Second Party at the beginning of each quarter. Payment will be made by the First Party within 30 (Thirty) days from receipt of the Invoice.

### Periodic Review:

The contract is effective from **01 January 2025** and will remain valid for a total period of 3 (Three) years. All the terms and conditions mentioned in this contract shall be reviewed / Amended [Mutual agreement] at the end of one year or as requested by either party.

### Termination:

- BdREN may terminate this agreement if **XYZ College** defaults in making the payments for two quarters.
- **XYZ College** may terminate this Agreement with prior written notice and serve at least of 2 (Two) months' before by making payment for the full quarter in which the agreement will be terminated.
- Both Party can mutually decide to terminate the contract with immediate effect. In such case the outstanding payment will be mutually settled.

In case of any sort of termination (other than mutually settled one), all the payments due shall be cleared by **XYZ College**.

THIS AGREEMENT IS A LEGAL BINDING BETWEEN **XYZ COLLEGE** AND BdREN. BY SIGNING BELOW, BOTH THE PARTIES WARRANT THAT, THEY HAVE READ THIS AGREEMENT IN ITS ENTIRETY, UNDERSTOOD IT AND THEREBY HAVE GIVEN THEIR CONSENT TO BE BOUND BY ALL OF ITS TERMS AND CONDITIONS, WHERE THIS AGREEMENT SETS FORTH.
